STOP POLITICAL REPRESSION IN THE BALTIC COUNTRIES!

5 March 2025

On 24 February 2025, the UN Security Council adopted a resolution entitled "Path to Peace", which radically changes the international assessment of the Russian-Ukrainian war. The resolution calls for an immediate end to the conflict. At the same time, unlike the UN General Assembly resolution of 2 March 2022, it no longer contains a unilateral condemnation of Russia.

While such permanent members of the United Nations Security Council as the United States of America and Russian Federation have actively begun work to end the military conflict in Ukraine, the authorities of the Baltic States - Latvia, Lithuania and Estonia - support the idea of continuing the war "until the victorious end" and promote the dissemination of military propaganda in the information space, part of which is the justification of the unprecedented restriction of the rights of their own Russian-speaking population.

Politically motivated criminal proceedings (for Latvia, under such sections of the criminal law as crimes against humanity, peace, war crimes, genocide and crimes against the state¹) are initiated against persons who dare to publicly express a position that does not coincide with the opinion of the authorities, rigorous proceedings involving lengthy pre-trial detention are conducted and real prison sentences are imposed.

While in 2019-2021 the Latvian State Security Service initiated 20-30 politically motivated cases per year, in 2022-2024 their number fluctuated between 47 and 64. In 2024, half of such cases were initiated under far-fetched pretexts of Russia's assistance in the fight against Latvia and Ukraine, which was expressed mainly in publicly expressing disagreement with the actions of the authorities.

The use of measures such as searches, detentions, confiscation of office equipment, restriction of access to bank accounts, pre-trial detention, denial of necessary medical care and other police restrictions during the investigation period is in itself a sensitive means of punishing and intimidating those who share the views of these victims of arbitrariness.

Today there are about 30 political prisoners in Latvian, Lithuanian and Estonian prisons who have become unwitting victims of the Russian-Ukrainian confrontation. We have made a description of some of these criminal trials of a political nature public,²³

The miting in defence of the politically repressed announced by the author of the appeal for 15.02.2025 was banned by the decision of Riga City Council .⁴

The current decision of the UN Security Council gives back to every inhabitant of the Baltic States the right to have and publicly defend their point of view on the events that took place on 24 February 2022.

We ask the leaders of the world powers who voted in favour of the UN Security Council resolution "Road to Peace" within the framework of bilateral contacts to call on the authorities of the Baltic States to stop criminal prosecutions on political grounds and to cancel the sentences that have already been passed.
